EU-related Working Group Update

The tremendous success of FS-ISAC led working groups has led us to create groups focused on EU-specific needs. Currently, the EU Threat & Strategy Committee and Insider Threat Working Group are active; a European Payments Risk Council is being developed.

Furthermore, we are collaborating with FSIE, CPNI, and CISP to create a common Working Group Framework / ToR that will allow us to cooperate with other entities that use Traffic light protocol on multiple topics, e.g. an overview of the threat intel sharing landscape in Europe or security and intelligence sharing process maturity.
